




Mt. SAC ISER Timeline



ISER Best Practices Used

- Emphasis is on <u>relevant</u> evidence
- Focus on the core and language of the Standard
- ISER Template & Guide closely followed
- Concise narrative to meet suggested page lengths
- Use of simple, clear, business-style writing
- Links to evidentiary documents with readers in mind
- Website evidence "Frozen" from websites (PDF)

- Indicates **WHAT** specific evidence demonstrates alignment with the Standard
- Briefly describes the evidence in its context to explain WHY it is relevant

- Indicates **HOW** the evidence demonstrates alignment with the Standard
- Evaluates the effectiveness of the policy, procedure, or practice

Conclusions (at the end of each major section)

- Summarizes the effectiveness of the College's efforts towards Standard
- May include improvement plans to strengthen alignment with the Standard




2024 Institutional Self Evaluation

Mt. SAC is conducting a self-evaluation and writing an Institutional Self-Evaluation (ISER) report in preparation for a comprehensive accreditation review which begins in Fall 2023 by the Accrediting Commission for Community and Junior Colleges (ACCJC). The public is invited to submit comments about Mt. San Antonio College to our accrediting body by completing a third party comment form on the ACCJC website.

The College Accreditation theme, "Weaving Our Story," has framed the self-evaluation work. As part of this process, Mt. SAC faculty, classified, confidential, managers, and students participated on teams to collect evidence and document the College's policies, processes, and practices towards meeting ACCUC Standards. The Mt. SAC ISER is being finalized in Spring 2023, with stakeholder review and input.


