H. COVID-19

C. Uyeki explained the various agencies and guidance Mt SAC has been following and recommended Senators review Mt. SAC.edu/health. She shared challenges various departments are experiencing, ideas from the Exec Board regarding attendance policies, Title 5 issues related to absences, reminded the body that all classes have a course shell in canvas, and encouraged faculty to begin prepping to transition to temporary remote instruction becomes necessary. C. Impara shared information about remote temporary instruction and recommended that departments identify, in a timely manner, courses that are able to transition modalities. Discussion continued as faculty including J. Sholars, K. Rivera, C. Cummings, B. Meyer, E. Rios-Alvarado, D. Miho, T. Anders, B. Lawlor, B. Nixon, G. DePaola, D. Rowley, J. Laverty, A. Wood, E. Versace, and S. Blackshear discussed a variety of issues and asked questions. Mt. SAC President Bill Scroggins stepped into the meeting during this discussion and, with the permission of C. Uyeki, answered questions and provided feedback.
