# D. Public Comment

- K. Allende: Thanks to the Racial Justice Task Force. It is important as educators to embrace our past commitments to racial justice, even if some of these recommendations make us uncomfortable.
- M. Shear: Dance department is worried about keeping classes with minimum enrollment of 12. They would like to keep lower enrollment numbers as we transition back to campus in order to support students in their educational goals.
- C. Cummings: Theater department would also like to call on academic senate for support of classes with lower enrollment numbers. Our department is working within a larger context of theater industry still rebounding. Even if student numbers are fewer, these remaining students need to have the full course offerings available in order to keep moving forward with their degrees. A single enrollment limit will disproportionately affect smaller departments like dance and theater.

# 3. Report

# A. President's Report

C. Uyeki: See attachments for info about managing re-entry anxiety: be kind to yourselves and your students. Will start by sharing info about Mountie Money Management Center (MMMC) and other Title V projects.

L. Amos: See files in BoardDocs, most of the focus today will be on MMMC, but other info is there and you are welcome to contact L. Amos with questions on any of it. MMMC is deliberately connected with all money-related services on campus (e.g. financial aid, career planning). One-onone financial counseling sessions, presentations, workshops. 20 workshops offered over spring semester, 490 attendees (mostly students but some employees). Best attended was financial preparation for transfer. Including drop in sessions, workshops, and 1on1, 947 students served (but this includes duplicates). Largely Latinx, many Asian students, ~reflects student composition overall. 80-90% of participants said that it was useful and they feel more confident. C. Uyeki: Thanks for sharing. We will hear from more Title V coordinators in fall.

# C. Racial Justice Task Force Recommendations

C. Uyeki: Note that a few edits were made in exec.

Move to approve by B. Meyer, second by S. Espy.

A. Tellez: Task force was formed to ensure that Mt. SAC is a campus committed to racial justice and equity. As we have seen, many examples of racial injustice over the past year, including the death of many Black and Indigenous People of Color (BIPOC). The task force developed this list of recommendations to guide senate action in the future. Note that these are recommendations, not policies – task forces do not create policy. \_\_\_\_\_

D. Golden: I support the idea in general but object to some of the specific language. Can I offer an amendment? C. Uyeki: Yes, you can. D. Golden: Motion to strike the language about white supremacy on 1<sup>st</sup> page in last paragraph. Strike "white supremacy". Second by M. Rickard.

K. Allende: Con. "White supremacy" is consistently removed from documents because it makes white people uncomfortable. As an educational institution we need to recognize that it exists and has an impact.

D. Golden: Pro: We are recognizing that there are racial inequities and that there are multiple perpetrators from all groups. This is more appropriate.

M. McGuire: Con: Adding to what Kristina spoke to, the term "white supremacy" is often misunderstood. It functions alongside racial injustice and cannot be separated from it. White supremacy is the structure under which racial injustice operates. This dates back to at least the colonial era, where racial categorizations arose and whiteness was deemed the supreme race. It is important to include in documents to recognize that this is the way in which racial injustice occurs.

B. Lawlor: We need to make sure that this document works for a broad range of campus. I have spoken to colleagues who will reject this out of hand if they are accused of being white supremacists. We want everyone to self-examine our teaching practices for things like microaggressions. White supremacy is more charged language than we need if we hope for full cooperation across campus.

A. Tellez: I recognize that white supremacy is heavy language and makes people uncomfortable. However we are founded in a system of white hegemony, and this is historical fact. This should not make people uncomfortable if they don't hold white supremacist beliefs. I am half white, but I have no difficulty recognizing that our system supports white people. This is not claiming that anyone in senate or across campus is racist, this is not an attack on people, this is an attack on white supremacy.

D. Golden: I am not a white supremacist, I find it offensive to imply that wanting to change the wording would make me a white supremacist.

M. Stewart: There may some confusion about the term "white supremacy" and people are disagreeing because they don't understand the term.

Motion to extend discussion on the proposed amendment to Action C passes.

M. Stewart: (con, continued) I think we're dealing with a misunderstanding of the term. We are calling out a system, not individual people. We need to fix the system, as well as individual behavior. All of us, including white and brown people, live in a system influenced by white supremacy. Could we add a footnote or explanation of white supremacy?

C. Uyeki: Could we make a friendly amendment to define white supremacy?

D. Golden: I would not accept that without seeing the language of the definition.

J. Hinostroza: (pro) I see this as a wording problem. Acknowledging the existence of white supremacy reads as "we are acknowledging white people as supreme". This may cause confusion.

K. Allende: (con) Yes, it is a loaded term. We need to fight for our students and show them we care. We need to recognize that the world in which they live is upheld by white supremacy. This country is built on white supremacy, and we live in a place where we are arguing this at academic senate.

D. Golden: (pro) When I say the term is loaded, I think that the term is unclear, and not everyone knows what it means. I think it could be replaced with more clear, concise wording.

M. McGuire: (con) The point of "white supremacy" as a term is that it does have clarity. It is not about individual white people, but about the structure around which the world functions. Our society, including the US and Los Angeles, is built around structures that allow white people to prevail in society in ways that are not available to people of color. This is a structure under which we all live. We cannot water down language.
