1. Minutes	1.1 Meeting minutes from November 9 th were reviewed.	1.1 Minutes approved with minor changes
2. CAI Updates	2.1 CAI conference was last Friday. A Chancellor's Office handout was distributed and contained CAI updates on Phase I (Fall 2017) and Phase II implementation. Twelve pilot colleges will participate in Fall 2017 assessments for Spring 2018 placements. Additional colleges can expect CCCAssess tests implementation after data from the original twelve pilot colleges is reviewed and any necessary adjustments are made. Phase I will include adaptive Math, English, and ESL tests, student reports with approved course placement recommendations to be used with multiple measures, aggregated class-level reports, ability to use high school transcripts as multiple measures, aggregate data exchanges and data collection, a feedback mechanism, and training for pilot college staff. Phase II will include a writing component of the English and ESL tests, listening component of the ESL test, assessment prep, multiple measures, data-warehouse for local researcher access, and back-up test bank.	

3.	Multiple Measures and MM Research	 3.1 All twelve pilot colleges will be using MMAP this coming fall. Without MMAP, CCCAssess test results will not show a placement to students. E. Hill-Enriquez will ask Michelle Sampat if SSSPAC can have a copy of MMAP questions. 3.2 Michelle Sampat is making an effort to bring John Hetts to Mt. 4.	Dual Enrollment	4.1 A handout of AB288 (Dual Enrollment) was shared and implications were discussed for Mt. SAC. Approximately 1,400 high school juniors took the AWE during Spring 2016 for Fall 2016 placement and a class of thirty took a dual enrollment ENGL 1A pilot located at Diamond Ranch in Pomona. Students will receive credit on both their high school and college transcripts. No additional high school juniors will be taking the AWE this year.	
5.	New Student Orientation	 5.1 New Student Orientation Pilot is on hold due to difficulties finding a pilot group. The traditional model of assessment, orientation, the career piece for Pathways, and a return visit for Ed Plan is still in place. According to T. Mauch, approximately 10,000 students take orientation online and 5,000 on campus per year. 	
6.	Math Preparation Lab	 6.1 Math Preparation Lab is a new area for students to prepare for the Math Placement Test. Math Info. Sessions are also offered and the center is open from 9:00-5:00pm. Zolita Fisher (manager with Student Services) will supervise the area. Review for math classes will be offered and math professors will be available in the center. Discussions are taking place regarding students completing ALEKS computer modules so they can retake the math placement test sooner than three months.
