Mt. San Antonio College requires the following fees

- Enrollment
- Non-resident tuition

The non-resident tuition fee shall be set by the governing board not later than March 1 of each year for the succeeding fiscal year, pursuant to Education Code 76140

The following are fees authorized by law

- Athletic insurance
- Auditing of courses
- Child care
- Community services courses
- Copies of student records, including expedited requests
- Credit by Examination
- Dormitory
- Health
- International students application processing fee
- Instructional materials
- Non-College physical education facilities
- Noncredit courses that do not collect apportionment (some exclusions*)
- Non-resident students capital outlay
- Parking
- Physical fitness test
- Refund processing
- Student Activities
- Student Center
- Student representation
- Telephone registration

- Transportation
- Use of facilities financed by revenue bonds

*Excluding English as a second language, citizenship, elementary and basic skills, and courses granting high school credit

Mt. San Antonio College does not charge the following fees prohibited by law

- Add/drop
- Apprenticeship courses
- Breakage fees
- Cleaning fees
- Distance education (other than the statutorily authorized enrollment fee)
- Field trip
- For certain recipients of the Medal of Honor and certain children of the recipients of the Medal of Honor
- For dependents of certain veterans
- For dependents of certain victims of the September 11, 2001, terrorist attacks.
- Late application
- Late payment
- Mandatory mailings
- Mandatory student activities
- Noncredit courses that collect apportionment
- Non-resident application for residents of other states
- Nursing/healing arts student liability insurance
- Refundable deposits
- Rental of practice rooms
- Required or funded services
- Special Admit/Dual Enrollment
- Student Body Organization
- Student Identification Cards
- Technology

The following fee categories reflect collection and refunds

- Fees to be collected when enacted by the Legislature following registration by the student
- Fees collected in error

- Fees refundable because of a reduction in the educational or community service programs of the College
- Fees refundable because of the student's reduction in units or withdrawal from an education program
- Fees refundable because of changes in law or regulation authorizing and establishing enrollment fees
- Notice to students of availability of exemptions from certain mandatory and authorized fees.
