Carolyn Kuykendall, director of the Honors Program, presented a report on the program, which was started in 1995. Two years later, Mt. SAC joined the Transfer Alliance Program with UCLA to assure transfer priority consideration for Mt. SAC students who complete the Honors Program. Currently Mt. SAC has nearly 800 Honors students, ranking Mt. SAC's as one of the largest community college honors programs in both California and the United States. Mt. SAC's transfer acceptance rate to UCLA is in the mid 80% range. Half of the Mt. SAC students accepted to Berkeley were from the Honors Program. In addition, UCI admitted all of the Mt. SAC Honors students who were eligible for acceptance.
