- Presented at the Senate Plenary on the history of the development of technology;
- Mike Gregoryk, Vice President, Administrative Services, and Gary Nellesen, Director, Facilities Planning & Management, reported that the College has received a grant from the Metropolitan Water District and Three Valley Water District to upgrade our irrigation management system to current technology. Gary anticipates this to take approximately six months, and acknowledged Cesar Castaneda for his work on this project;
- He introduced Barbara McNeice-Stallard, Director, Research and Institutional Effectiveness, and Madelyn Arballo, Dean, School of Continuing Education, to present on the 2016 Scorecard. (Note: The presentation may be found on the College website with these minutes.)

#### Discussion:

(Scroggins) The scorecard also has a metric that counts the wage gain for the students who complete the non-student certificate, which is about at 20%.

(Hall) Who gets the scorecard and what do they do with it when they get it?

(McNeice-Stallard) The whole world gets the scorecard. After it is formalized, the CCC Board of Governors presents it to the legislature and governor as an evaluation of the community colleges and their performance; it's an accountability and transparency process. What they do with it beyond that, Dr. Scroggins, would you like to comment?

(Scroggins) Yes, it's one of the factors in the Strong Workforce performance—in the Salary Surfer. It's an accountability system. It's featured prominently in the Legislative Analyst's reports about the performance of the system. It's just that.

(Hall) They crunch it down to an overall metric for the whole system? I'm sure they don't present however many of these.

(McNeice-Stallard) No, they actually have it online; there's a one-pager for each College so you can pick a college.

(Scroggins) The report to the legislature was comprehensive; the last one was about 26 pages. It's a lot of analysis.

(Malmgren) One of the original motivations for the Scorecard by our past chancellor was to provide an opportunity for parents to understand the difference if their students come prepared to college as opposed to if they come in below college level. It was intended to be an informational piece and a motivator for students to continue to take their A-G and taking math and English through all four years of high school. That's where it started and it has expanded to take on other metrics, as well.

(Hall) Does it actually go out to the general public in some way?

(Scroggins) It's online. All of this information is online in a very consumable format. California leads the nation in having the data to do this kind of analysis. It helps us when we do the

student success report. It doesn't just happen elsewhere and it's really useful to convince the legislature that we're doing a good job. As Barbara pointed out, the upward trends show the impact of these initiatives that we're working on and is a key element to keep the money flowing.

(Baca) This was one of the things that Governor Brown was really impressed with. It's more straight-forward than we've had in the past. It does feed in to such things and ties in to the Salary Surfer. The central focus is to be more transparent and get more information out so that students and parents know what they've got.

(Scroggins) I use this information in community presentations.

(Baca) One of the things that colleges don't have is they don't have a Barbara. A lot of the work isn't at the state level, but very much at the colleges. You do a very great job at this.

(McNeice-Stallard) If I may advocate for something, with respect to the wage data, one of the issues that we have is it does not show everyone. Students who graduate and go out into the workforce as their own consultant or as a government employee are not represented in the wage data. It would be better for the wage data to come from the IRS. Again, they don't all stay in California. It was hard for the Chancellor's office to collect the EDD data.

(Baca) I agree. It's something that should be worked on. The idea is a good one, but is a work in progress.

(McNeice-Stallard) It's good, but I want to find more.

#### Academic Senate Report to the Board of Trustees November 9, 2016

#### **Full Senate Activity**

The full Senate met on October 13. At the meeting, the Senate:

- approved the 2016-17 Senate goals and strategic objectives
- approved a CTE advisory committee proposal
- discussed the dissolution of the Professional Relations Committee

The full Senate met again on October 27 to discuss the resolutions for the Academic Senate for California Community Colleges' plenary session.

The full Senate will next meet on November 10. At the meeting we will confirm several council and task force appointments.

#### Senate Goals and Objectives for 2016-17

As the result of a planning retreat and deliberation by the Executive Board and full Senate, the Senate has adopted an agenda of strategic objectives for 2016-17. As part of the process, the Senate will be convening task forces to work on the following topics: dual enrollment, assessment preparation, adjunct integration to the campus community, the College equivalency process and procedures, sustainability practices in the Senate, and the pending integration of Basic Skills, SSSP, and Student Equity Plans by the Chancellor's Office. The Senate will also begin considering resolutions on faculty participation in decisions during intersessions, creation of additional classroom and lab space, providing additional support services for evening and late start students, recommending the creation of designated space for make-up or accommodated testing, encouraging faculty to use the early progress report system, and recommending pay for adjuncts who participate in professional development. We welcome input from the Board on these topics and look forward to sharing the Senate's positions and advice with the Board of Trustees.

#### Faculty Hiring Prioritization

The Senate Executive Board met to discuss and rank faculty hiring requests on Friday, October 14. The top 30 positions were ranked. The Academic Mutual Agreement Council (AMAC) met on October 24 and compiled the Senate and Instruction Team's rankings into a single list which was submitted to the College President. At the Cabinet meeting on October 26, the President authorized the first 13 hires from the list.

#### ASCCC Fall Plenary Session

On November 3-5, Michelle Sampat, Martin Ramey, and I attended the Academic Senate for California Community Colleges Fall Plenary session in Costa Mesa. Michelle presented a breakout session on curriculum and the Strong Work Force recommendations. I presented at the general lunch session on Mt. SAC's work on the AACC Pathways Initiative. I also attended breakout sessions on accreditation and SLOs, surviving an accreditation visit, pathways work being done at other colleges, and the Common Assessment Initiative. On Saturday, a variety of resolutions on academic and professional matters were discussed.

Several themes emerged in the breakout sessions and plenary resolutions: 1) faculty continue to be concerned about their involvement in developing and monitoring the quality of dual enrollment programs to ensure the highest academic standards; 2) accreditation, in particular inconsistent evaluation of colleges on the new ACCJC standards and ACCJC's relationship to the ASCCC on the issue of the baccalaureate pilot program and the appointment of faculty positions on the ACCJC; 3) the rollout of Common Assessment and the Multiple Measures Assessment Project (MMAP), specifically ensuring validity, no disproportionate impact, and local faculty input on how campuses use the state's multiple measure process; and 4) responding effectively to the Strong Work Force recommendations in a way that ensures faculty voices are heard and valued in decision-making processes.

I also wish to commend our noncredit faculty, Dana Miho and Donna Necke, and Dean Madelyn Arballo for crafting a plenary resolution requesting a modification of the standard CCCApply form to provide better service to our noncredit students who face unique challenges when entering college. Their resolution was adopted, but most importantly the discussion around it brought attention to an important issue for our noncredit programs and to the barriers to enrollment erected by the state for some of our noncredit students.

On tonight's agenda you will be asked to determine whether the District will ratify the 22 tentative agreements modifying the contract between the District and the FA. I am pleased to announce that the faculty have ratified the contract with 89% of the members voting in favor. The FA has also completed its negotiations survey for 2017. We expect that our proposals will be presented to the Board of Trustees at your January meeting.

#### 2. Representative Council

At its last meeting, the FA Representative Council approved a task force that will investigate the needs and interests of our adjunct faculty. In addition, we will request NEA's assistance in reaching out to our adjunct faculty. 





# **Strong Workforce Program Funds**

- In response to the CCCCO's Strong Workforce Task Force
  Recommendations, Strong Workforce Program (SWP) funding was
  written into the California budget through <u>Assembly Bill 1602</u>.
- California's community colleges will receive \$200 million annually for both local and regional projects designed to improve career technical education programs by:
  - (1) adding new career pathways
  - (2) increasing the number of skilled workers they produce
  - (3) increasing faculty numbers
  - (4) strengthening curriculum
  - (5) improving regional cooperation among colleges, K-12, industry, and other work force groups



#### Annual Supply & Demand (2015)





- All projections must be based on information in the LaunchBoard








## **Regional Planning Process Flow Chart**
