Whereas: The current responsibilities of the Political Senator in the Organizational Directive are outdated and lack detail pertaining to the commitment required of the position. The current formatting of the Political Senator position should also be revised for organization and clarity purposes.

Therefore: The following changes shall be made to the Political Senator position:

Line #2 "Serve as the Mt. SAC A.S. voting representative to region VIII, if A.S. participates"

Line shall be expanded to detail delegate responsibilities in full. The following shall be a subsection under this point, "attend SSSCC General Assembly as Mt. SAC delegate (subsubsection: Report actions made at SSSCC GA back to Senate), attend monthly delegate meetings, complete reports pertaining to Mt. SAC A.S activity and delegate responsibilities, participate in 1 internal regional committee (if available)"

Line #3 "Issue recommendations to Senate pertaining to important legislation supported"

Line #3 shall be removed as Associated Students is a non-partisan organization and the Political Senator should not be enforcing their own political beliefs or recommendation onto the organization.

Line #4 "Promote 'Chat with the President' events"

Line #4 will be updated to read "Collaborate on campus advocacy and civic engagement events" to ensure the Political Senator is promoting and engaging campus events related to their purview.

By implementing these adjustments, the Political Senator's responsibilities provide clarity regarding the commitment and expectations for said position.
