Dives into what kind of data reporting was conducted: “college leaders understand where we’re going with equity teaching and data coaching.” Looking at Equity program for equity teaching for data to better understand Latinx communities. • Cathy reports milestones from piloted studies: Becoming a data literate educator, data coaching program, first cohort of data coaching in spring 2021. Student success data where cohort training with CORA: Racial macroaggressions and unconscious bias. Another cohort training with CORA: Best practices for teaching at a Community College, ACUE affective teaching practices cohort. Result of these trainings illustrate: success rate of students of faculty who participated in the CORA trainings really didn’t change much over student who were in none CORA trained courses. • Student success on ACUE training faculty, 3.5% increase for those students over the non AQ training faculty – this determined what the future of faculty trainings would look like for spring. • ACUE-ITEL : Inclusive Teaching for Equitable Learning – collecting data on those teaching practices • Oli Mohammadi – onboarding to the Title V grant – appointed by academic senate, - she is doing the online virtual aspect of what Mica Stewart is doing on ground. Her project will be explained during next meetings so she can share more aspects of her work
